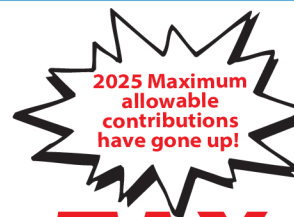

# It's Tax Credit Time!!!

## FREQUENTLY ASKED QUESTIONS ABOUT THE ARIZONA CHARITABLE TAX CREDIT

*Always Consult Your Tax Advisor!*

### Q What is the Arizona Tax Credit for Charitable Organizations?

A You may claim a tax credit for voluntary cash contributions you make during a taxable year to a qualifying charitable organization.

### Q Is this the same as the School Tax Credit?

A Yes. It is similar, but taxpayers are allowed to take advantage of both tax credit opportunities.

### Q How much can I give?

#### A **Maximum limits have gone up again for 2025!**

Married couples filing jointly can contribute up to **\$987**. Individual filers can contribute up to **\$495**. This is not the required amount- any amount will do! You can also make incremental cash contributions.

### Q Do I have to itemize my deductions to claim the credit?

A No. Any taxpayer who donates to a Qualified Charitable Organization may claim a tax credit.

### Q How does it work?

- A
1. Make your specified Charitable Tax Credit Contribution to the **Boys & Girls Clubs of the Sun Corridor**. The deadline to make this contribution has been extended to **4/15/26**.
  2. The Boys & Girls Clubs of the Sun Corridor sends you a receipt. Hold on to it!
  3. When filing taxes in the spring of 2026, include your tax credit to calculate a lesser liability or a greater refund.
  4. The resulting figure is what you actually owe Arizona for 2025 or will be refunded by the State.

### Q What if I owe the state a remaining balance?

A For example: If you have a remaining state tax liability of \$856, since you donated a \$495 (single filing) tax credit in 2025, you immediately reduce that figure to \$361. That's the final amount of state tax you owe.

### Q What if the state owes me?

A For example: If you are due a refund from the state of \$200, since you donated a \$987 (couple joint filing) tax credit in 2025, you immediately increase that figure to \$1,187.

### Q Do I claim my Charitable Contribution as a tax credit or a deduction?

A Your Charitable Contribution can be claimed as a tax credit since the Boys & Girls Clubs of the Sun Corridor is considered to be a Qualifying Charitable Organization. **Please note, you cannot claim both a deduction and a credit for the same charitable contribution on your Arizona tax return.**

### Q Are there other restrictions?

A If you have a very low taxable income, you could have state tax liability of less than \$987. You might end up going beyond your tax liability. If in doubt, check with a tax advisor.

### Q What is your QCO Code?

A All certified charities have been assigned a QCO (Qualifying Charitable Organization) Code. Donors will be required to use this code when taking the tax credit on their income tax returns. Our QCO code is 20360.
